Yorkshire solicitor among first to qualify through SQE exam

A Yorkshire solicitor has become one of the first in the country to qualify through the SQE exam. In 2021, this new route was introduced, designed to assist candidates from non-traditional legal backgrounds in entering the field of law.

Brittany Clark, a solicitor at law firm, Holden Smith, has qualified after two years studying the solicitors qualifying exam (SQE).

During her studies at The University of Law (ULaw), Brittany also worked at Holden Smith. This allowed her to prepare for the two-stage SQE assessment while bolstering and developing her skills working in legal practice.

Ms Clark said: "I'm delighted to be one of the first in the UK to qualify as a solicitor via this new route.

"The SQE has revolutionised the way in which solicitors can train, promoting social mobility and diversity in the legal

profession, and opening the doors of a career in law to people who may not have considered it, or thought it was out of reach.

"Qualifying via this route meant I was able to gain valuable, on-thejob experience and learn from my colleagues at Holden Smith, while also earning a salary from day one." James Smith, co-founder and



director at Holden Smith, said: "Until recently, the route into a career in law has been very prescriptive, but things have moved on. At Holden Smith, we welcomed the introduction of the SQE, because being able to recruit solicitors from a diverse talent pool is key to the future of our practice."

IDR Law debuts charity claim checker for legacy gifts

Fletchers Group partners with the University of Liverpool for legal AI project

Fletchers Group has partnered with the University of Liverpool for the second time, undertaking a new legal Al development project.

This partnership will build on the group's work on SIDSS (structured information decision support systems). Fletchers states that this system has saved "tens of thousands of hours" in staff time. The firm uses the system to decide whether to investigate and take on clinical negligence cases.

Professor Katie Atkinson heads up the Univery of Liverpool's computer science team. Fletchers is sponsoring two PhD students to complete their doctorates by undertaking research for the new project.

Furthermore, Fletchers has appointed Noah Milton into a new role of Al project director. As a result, he will head up the development programme. A new head of data science, Quentin Debard, has also been hired to complete the team.

Dan Taylor is Fletchers' director of integration who led the creation of SIDSS. He stated that the partnership with the University and the two new specialist appointments underscores the firm's appetite to become a "pathfinder and innovator for the use of AI in the law."

Speaking about the vision for the upcoming project, Noah Milton said "We want to build and deploy tools which make use of the latest AI technologies, including large language models (LLMs), to support our colleagues, improve automation of simple tasks, and bring our collective business expertise to our lawyers and make it work for every one of our clients."

With the key players appointed, the partnership kicked off in November 2023.

Funding for the four year multi-million-pound project will be through Fletchers as part of its long-term commitment to Al research in the law.

As president, I have been delighted to support the society and community in a number of ways, including by attending the 'annual legal service' at York Minster in October, judging the Yorkshire Legal Awards 2023, and attending the Accountant's Society earlier in the year.

All of these events are great for networking to meet more legal professionals in the area and advertise the society/firm.

Natalie Prowse, the society's honorary secretary, is a senior lecturer in law at the University of Huddersfield. Her connection allows committee members to support the university through attending their mentoring events and prize giving service.

This year, we have also seen the reignition of the 'Kirklees & Calderdale Junior Lawyers Division', which has succeeded in its first few events that have taken place over the last 6 months, including the launch event, personal

Reflecting on Leeds JLD's Support for Andy's Man Club

Sophie Hudson, a commercial litigation associate at Weightmans LLP and charity & education officer for Leeds JLD, reflects on a year of supporting Andy's Man Club.

What is Andy's Man Club?

This year Leeds JLD voted for Andy's Man Club to be its charity of the year. Andy's Man Club is a men's suicide prevention charity that offers free-to-attend peer-to-peer support groups across the UK and online. The charity started in Halifax in mid-2016 with 9 men and has since grown to open over 150 in person clubs. Over 3000 men use the service on a weekly basis with over 900 having become facilitators of the club, to continue to grow and support every man that walks through their doors.

Suicide is the biggest cause of death in men under the age of 50 and around three quarters of the deaths from suicide each year are men. Andy's Man Club is there to prevent those deaths where they can, being there to listen and remind men everywhere, that #itsokaytotalk.

How has Leeds JLD supported Andy's Man Club this year?

All of Leeds JLD's fundraising efforts in 2023 have gone directly towards raising money for Andy's Man Club. Any event that was free for members, had a £4 charity donation charge for non-members to attend, which quickly built up the fundraising with sell-out events being common throughout the year.

At our summer party in July we held a raffle that raised over £400 for Andy's Man Club, followed quickly by our charity netball tournament in August, raising £600. This got the year of fundraising off to an excellent start, but Leeds JLD really kicked it up a notch at the winter ball with great generosity from all the members that attended. In one night, we raised a massive £2,209.12 (nearly as much as the whole fundraising year for 2022). We cannot thank our members enough for their support towards Andy's Man Club and all the amazing companies that donated to make the raffle possible.

The Leeds JLD fundraising total for 2023 has reached the highest figure ever raised, with a whopping $\pm 3,418.12$ raised.

Andy's Man Club isn't just all about raising money though, but also awareness too. Spreading the word is just as important and we were delighted to welcome Andy's Man Club to present at this year's mental health talk event on 27 April 2023. We were joined by wonderful facilitators of Andy's Man Club, who were supported by their local clubs





and went on to be those supporting others. They shared their very personal stories of what a difference Andy's Man Club made to their lives and how they

would not be here today without those clubs. In addition to this, another three amazing facilitators joined Leeds JLD for the winter ball and spoke about the impact of Andy's Man Club in front of 225 members. We are incredibly grateful for the facilitators who continue to share their stories and the importance of Andy's Man Club.

Intellectual property expert weighs in on the Beatles' use of AI in new release

On 2 November 2023, The Beatles released what has been deemed their final record with the use of Al. John Lennon's vocals as well as shelved pieces of George Harrison's work have been combined with new work from Paul McCartney and Ringo Starr to create 'Now and Then'.

Paul McCartney, Ringo Starr and George Harrison have previously collaborated to release 'Free as a Bird' and 'Real Love'. These tracks used John Lennon's vocals after his passing. The band never released 'Now and Then' due to technological issues with the track. Therefore it has laid dormant until now.

Director Peter Jackson and his team have developed cutting-edge technology using machine learning and AI. This technology allows the user to split tracks into separate components. This development has allowed the remaining two Beatles band members to revisit this track and produce it as potentially the final Beatles release.

Considering that two members of the band have passed, the track has called into question many legal points surrounding ownership and consent. Technically, all four band members have been a part of the creation of 'Now and Then'. However, nobody can say for certain that Lennon and Harrison would have provided their consent to produce their work in this manner.

Alan Harper, partner at Walker Morris and intellectual property expert, has weighed in on the ongoing discussion surrounding the Beatles' new release.

"It is fair to say that the AI revolution has captured the public's imagination this year through the wider availability of AI tools such as ChatGPT and Midjourney.

"A further example of AI being used in a way that is of interest to the public is the recent release of "Now and Then" by the Beatles. To create the song, AI tools were used on a demo recording from John Lennon back in the 1970s.

"The output of this process was a vocal recording which could be mixed in the usual way. Not only does this showcase what AI is capable of, highlighting another potential use case, it also raises a number of interesting legal points, in particular the question of ownership. These are questions which will need to be tackled and will no doubt create much legal discussion.

"I am dealing with AI related queries more frequently and providing legal advice based upon the law as it stands. However, some questions cannot yet be answered, and businesses need to be mindful of the issues and risks."



New high sheriff of West Yorkshire selected for 2024-25

The nominating committee has selected professor Adeeba Malik CBE DL as the new high sheriff of West Yorkshire for 2024-25.

The lords of the council in the King's bench division of the high court of justice make the annual nominations. It is presided over by the lord chief justice and was held this year on the 13 November. The new high sheriff will take office at the declarations ceremony in March 2024.

Adeeba is the deputy chief executive of the QED Foundation. She has worked with the Bradford ethnic minority-led charity for over 32 years.

Adeeba started out as a teacher in Bradford and Hull. She has dedicated her career to creating social and economic opportunity for minority ethnic groups in the UK.

She has won many accolades and awards over the years. These include the Yorkshire Post Top 20 Influential Women of Yorkshire and Top 50 Northern Power List for Women. In 2023, she was the recipient of Woman and Home magazine's, Amazing Woman Award.

Adeeba received her MBE in 2004, and a CBE in 2015 for her contribution to mainstream public bodies.

The office of high sheriff is carried out on a wholly voluntary basis. It is a non-political one-year role appointed by the crown



that represents the King in West Yorkshire in upholding all matters related to the judiciary and law and order.

Dr Mohammed Ali OBE, CEO of the QED Foundation, said: "I'm immensely proud of Adeeba and all her achievements over the years. This nomination is testament to her passion, integrity and dedication; qualities that have played a vital role over the years helping to make QED the force of good it is today."

Adeeba said: "I'm deeply honoured to be nominated for this prestigious role."

Switalskis expert raises concerns over Operation Stovewood transition



Amy Clowrey, director and solicitor within the child abuse department in Wakefield-based Switalskis has commented on the recently announced transition for Operation Stovewood The National Crime Agency (NCA) is transitioning

Operation Stovewood, the most extensive investigation into child abuse in the United Kingdom. Launched in 2014, the operation focuses on non-familial child sexual exploitation in Rotherham spanning from 1997 to 2013.

Over the past nine years, NCA officers have made significant strides, resulting in over 200 arrests and 26 convictions. With more than 50 active investigations ongoing, the agency has identified over 1,100 victims and engaged with as many as possible. Despite the NCA's commitment to seeing ongoing cases through the criminal justice process, a new phase is set to begin on 1 January 2024.

From that date forward, the NCA will no longer initiate new investigations under Operation Stovewood. Instead, South Yorkshire Police will handle any new allegations. Philip Marshall, head of investigations for NCA Stovewood, emphasised that while the agency will cease opening new cases, they will continue to prioritise existing investigations and treat victims with the same dedication.

Marshall stated, "We remain determined to seek justice for as many victims as possible". The transition aims to be seamless, ensuring that individuals coming forward after 1 January 2024, will receive consistent support.

Amy Clowrey commented on the change of hands. She stated that she believes the transition to be premature whilst so many criminal investigations are still ongoing. Amy also highlighted that many women repeatedly went to South Yorkshire Police to tell them what was happening to them at the time and were not provided with support. Therefore, there is a lack of trust with South Yorkshire Police due to historical failings. She stated; "I think I think it's a hard one for them, for the women to digest. And I worry that it will mean that less women are willing to come forward."

"I do hope that they've learned their lesson from the past and that they've got a good team set up in light of the fact that everything's going to pass back over to them."

Operation Stovewood stands as the largest law enforcement operation of its kind in the UK, unprecedented in scale. The convictions secured thus far have resulted in cumulative jail sentences exceeding 260 years. Neil Cawton's recent conviction, the 26th since Stovewood's initiation, highlights the operation's continued success in bringing offenders to justice.

Rothacs continues to provide support to survivors of abuse in Rotherham.

The charity's core mission is to support research into new cancer treatments and address challenges faced by long-term survivors.

On 9 November 2023, Paul shared news of a breakthrough in research funded by Team Verrico in the journal Frontiers in Immunology. The studies address ways to identify high-risk relapse cases and inform decisions about immunotherapy as a secondary treatment.

The ongoing research focuses on women with TNBC susceptible to metastases within three years of treatment. Professor Claire Lewis leads the study, aiming to bring findings closer to routine application in UK oncology clinics, with a cost of £52,000.

Paul has raised £11,000 from his first marathon, with an additional £10,000 pledged by clients. Planning to run 10 marathons in 10 months across 10 countries, he aims to raise awareness and secure funding for the second stage of the study. The charity's mantra, "never give up!" drives Paul's commitment.

Sarah Khan-Bashir, SKB Law

Sarah Khan-Bashir. The founder of SKB Law, who was also named Yorkshire Lawyer of the Year 2023 at the Yorkshire Legal Awards, discusses her career in family law

What inspired you to focus on family law and the South Asian community's marriage law issues?

I realised family law was for me during one of my first divorce cases twenty-five years ago. My client was a South Asian woman who'd experienced domestic abuse. She came to us from another practice after feeling her previous solicitor didn't understand the nuances of getting divorced in South Asian culture. She told me:"I sat in front of you, and you just got it." It emphasised the importance of diversity in the law and I still get goose-pimples just thinking about it. I hope that my work, and that of my firm's, is helping to build a more inclusive and culturally responsive legal sector.

Could you share some of the major challenges you faced early in your career and how you overcame them?

My journey into law was unconventional — from a background in chemistry and agrochemicals to changing careers to law. The initial transition was challenging; I felt disoriented during my legal practice conversion course, and faced rejection letters, a lack of role models, and no clear route for career progression. I persevered and finally entered family law, almost by chance, through a temporary work experience position. My offer to work for free for three months landed me my first job in the legal sector, and I took a chance starting a law firm from scratch, and today's it's an award-winning firm!

Can you share some insights into your leadership style and how it has contributed to SKB Law's success?

I've had the privilege of supporting individuals at various stages of their legal careers, from trainees and work experience students to seasoned professionals. I've learned that effective leadership is about sharing knowledge, creating a welcoming environment, and nurturing a workplace where individuals feel safe to explore their potential, learn from mistakes, and truly be themselves. There is no top-down approach; if someone has an idea, we give it a chance. Family law can be demanding, so it's also important to maintain a supportive and fun work culture.

How do you ensure that SKB Law's services are accessible to a wide range of individuals, regardless of their background?

My firm's tag is 'family law, done differently'. It's our mission to improve access to the law. We do this in several ways. For our clients, we strive to make our legal services inclusive by offering multilingual support, culturally sensitive advice, and flexible consultation methods. For the public, I've created a number of free resources to improve awareness about legal rights, including my podcast Family Matters, sharing real stories and insights on divorce in the South Asian community. The firm's academy also offers work placements to local students seeking to gain legal insights.



What do you find most rewarding about being part of the workforce in Yorkshire, both in terms of your career and personal life?

Yorkshire has a strong sense of community - it's the place where I was born, educated and raised my family. For me, the most rewarding part is being able to give back - to make a difference in the lives of individuals and the wider community here.

What are some of the most rewarding aspects of your work in family law and community advocacy?

The most rewarding aspect is witnessing the positive impact on individuals and families when they receive the legal support they need. Knowing that every day, I help someone through a life-changing event, to protect their rights, see their family and resolve conflicts.

You won Yorkshire Lawyer of the Year 2023 at the Yorkshire Legal Awards, which is an incredible achievement. What advice do you have for individuals striving to make a significant impact in their respective fields and earn similar recognition?

Stay committed to your values and the reason you entered this field. Don't be afraid to reach out and collaborate with others, working with others can lead to greater achievements. I remember returning to my table at the awards and hugging my team, knowing that my award wouldn't be possible without our collective effort.

What motivates you to continue pushing for positive change and better representation in the legal field?

In family law, the impact of our work can last a lifetime for our clients. To better understand their needs, the legal field needs to reflect the society it serves at all levels.
